Our colleagues, partners and beneficiaries came up against barrier after barrier in our programme countries, such as conflict, discrimination against people with disabilities, and a severe lack of resources for eye health, education and employment. The COVID-19 pandemic continued to wreak havoc on our programme countries, especially in terms of economic impact. But, through resilience and passion, we achieved incredible change!

Last year, we provided access to eye care, education and work for some of the poorest and most marginalised groups. We reached more than 791,000 people.

What's more:

- + Our comprehensive child eye health programme "1,2,3 ... I can see" began.
- + Our impactful Disability Inclusion Facilitator model for economic empowerment took flight.
- + We kicked off an ambitious inclusive education project in Burkina Faso, which will eventually make 40% of all schools in the country inclusive.

- + We began new humanitarian outreach programmes for people with disabilities in crisis situations in Cabo Delgado, Mozambique, with the support of the Austrian Development Cooperation and UNICEF.

These are just a few of the successes your continued partnership and support made happen these last twelve months. Read on to enjoy more stories of impact and inclusivity.

Our work is made possible by our generous donors including from our member organisations in Austria, Belgium, Czech Republic, Germany, Switzerland, UK and USA.



Highlights 2021

We reached **791,000** people in all their diversity with crucial support, including eye health, rehabilitation and education.

Additionally **7.3 M** doses of medication against diseases like Trachoma were distributed.

Eye health

Without drastic action, global demand for eye care is set to triple by 2050. Light for the World focuses on accessible and affordable eye health for all, integrated into health systems. Last year we increased support among massively under-resourced communities:


- + Our comprehensive child eye health programme “1, 2, 3 ... I can see” began in Burkina Faso, Ethiopia, Mozambique and Uganda to make children’s services more available and affordable.
- + We launched a “first of its kind” toolkit to combat glaucoma, the leading cause of irreparable blindness across Sub-Saharan Africa.
- + We joined partners in successfully lobbying the UN General Assembly to adopt the “Vision for Everyone” Resolution, to ensure eye health for the 1.1 billion people living with preventable sight loss by 2030.
- + Our Neglected Tropical Diseases work in Oromia, Ethiopia, continued, despite many challenges; and the Ethiopian Ministry of Health approved a national school eye health manual for teachers.
- + We began implementing a trailblazing programme in three African countries to help close the gender gap in eye health, through generous support from the Austrian Ministry of Social Affairs and Health.

In 2022, we are working hard to ensure even more inclusive eye health services to dismantle many of the barriers women and people with disabilities face in their access to care.

Inclusive education

Children with disabilities are often denied their right to education. COVID-19 related school shutdowns have caused even more hardship. Inclusive education is needed now more than ever. Our 2021 work included:

- + The kick-off of an ambitious new project in Burkina Faso which, together with the Catholic Education Secretariat, will eventually make 40 % of all schools in the country inclusive.
- + Successful campaigning towards a new national Inclusive Education Policy in South Sudan, ensuring children with disabilities access to a quality education.
- + Together with Mastercard Foundation, launching the CapAble platform to promote disability inclusion in Higher Education.
- + High-level advocacy with partners at the Global Education Summit around International Education Day and towards Global Partnership for Education’s “Raise your hand” campaign for education.
- + Celebrating with Hamele & Yekatit schools in Ethiopia which, supported by Light for the World and local partners, were delighted that all deaf students passed their exams.



Work

People with disabilities want to earn and learn but are often shut out of the job market. We support programmes which strengthen employment opportunities, including:

- + Our brilliant Disability Inclusion Facilitator programme which now has youth role models in Bangladesh, Burkina Faso, Ethiopia, Kenya, Mozambique, South Sudan and Uganda beyond—ensuring more and more people with disabilities have access to work.
- + Our partner Uganda Business and Disability Network, which grew from strength to strength in 2021, and now includes some of the country's largest companies.
- + Our work on Inclusive Futures, funded by UK Aid, which supports people with disabilities in Bangladesh, Kenya and Nepal to access livelihood opportunities.
- + Our Kenyan InBusiness programme, which received official recognition for exemplary service.

In 2022, we roll out our economic empowerment programme across Burkina Faso, Malawi, Mozambique and India, including 60 Disability Inclusion Facilitators, two innovation labs, and one new cross-regional learning route for awareness raising.

Amplifying voices



The voices of people with disabilities are key to a more equal world—so we are delighted that:

- + Our global advocacy, in partnership with the World Federation of the Deaf, made waves around under-representation of deaf people in the UN.
- + Gamze Elibol, Bernice Oyeleke and Robbie Francis Watene received Light for the World's Her Abilities Awards, celebrated by Austria's First Lady Doris Schmidauer.



TRANSPARENCY & ANTI-CORRUPTION
